Narellan Franchise Pty Ltd v RBME Pty Ltd [2023] NSWCA 139 - led by P M Knowles SC – enforcement and reasonableness of franchise restraints of trade, whether first instance decision interlocutory

**QB4 Capital Pty Limited v Guardian Securities Limited** [2023] FCAFC 72 - led by F M Douglas KC – trustee rights of indemnity under a registered managed investment scheme, repayment of monies under terminated deed of settlement
